## **Election Results**

This information highlights the process and results of the 2025 Aramco Brats, Inc. (ABI) Board of Directors Election, made available for ABI member review. Per the ABI Bylaws, the winner of each elected position is determined by a simple vote majority. As they nor any other immediate family member or spouse were present on the ballot, the Election data and results were reviewed and ratified by Marie Littlejohn-Dunn – DH '77, Liz Germani – RT '84, and Steven Owen – DH '08. In total, 444 validated votes were received across the four open positions: **President**, **Vice President**, **Secretary**, and **Treasurer**. The results were as follows:

## **Communications and Election Process**

The Call for Nominations for the 2025 ABI Board of Directors Election was opened on March 11, 2025 and closed on April 15, 2025. The notification e-mail contained a link to the <u>Get Involved</u> form on the Aramco Brats website, where nominees were asked to provide their first name, last name, e-mail address, 9<sup>th</sup> grade graduation year/district, his/her choice of elected and/or appointed position, and text to explain pertinent skills and why he/she would be a good candidate for the role chosen. The e-mail also provided a link to the "Article 4: Board of Directors" section of the ABI Bylaws so members would understand board position responsibilities.

The commencement of online voting for the 2025 ABI Board of Directors Election was notified to members via e-mail on May 22, 2025. The e-mail contained a secure link where members could view information concerning each of the nominated candidates, and an electronic ballot for members to vote on their selection for each office. The ballot required selections to be made of each office for validation, with ability to submit a write-in candidate as opposed to the person nominated. All voters received a confirmation e-mail indicating their votes had been recorded.

Voting was permitted up to 3:00pm Eastern Daylight Time (EDT) on June 28, 2025, and Election results were reviewed and ratified upon closing. Election results were announced at the ABI Reunion Banquet conducted during the evening of June 28, 2025.
