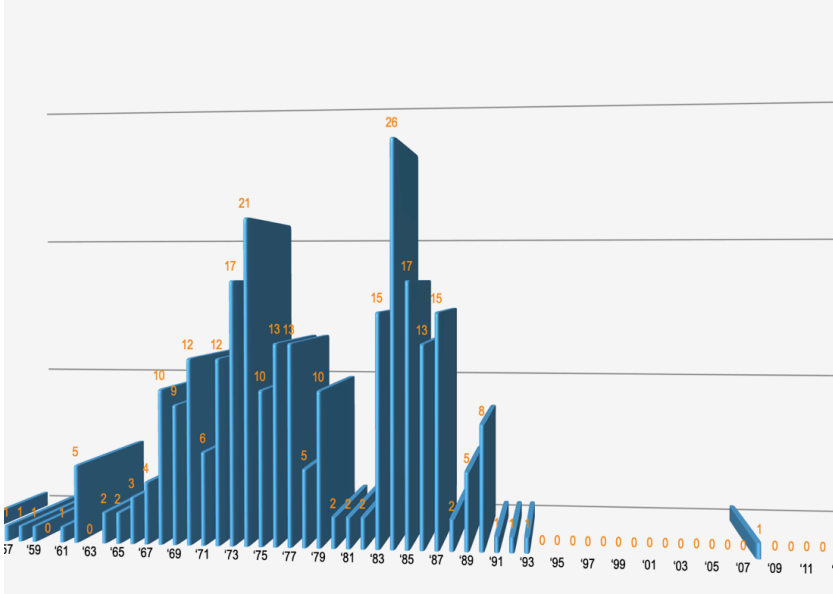

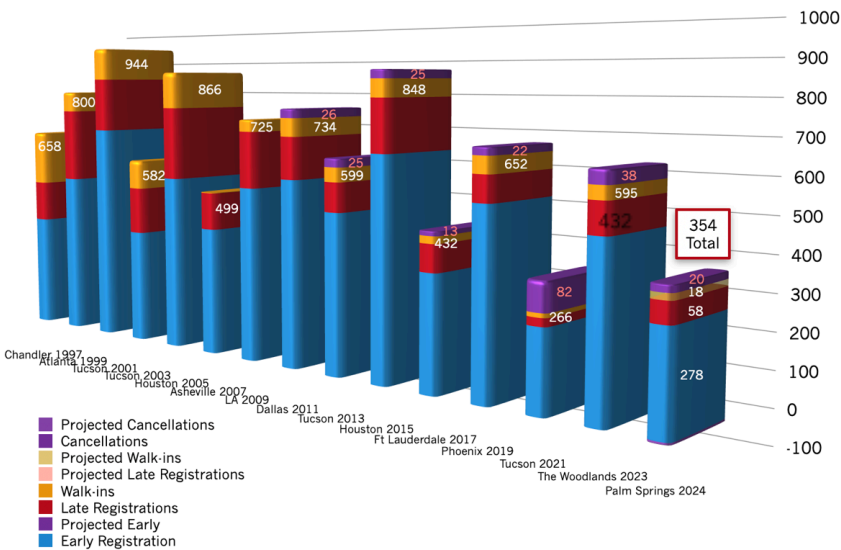

## Board Accomplishments This Term

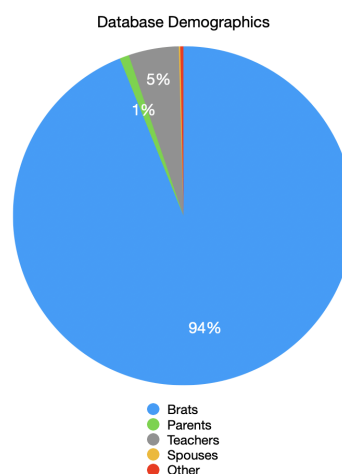
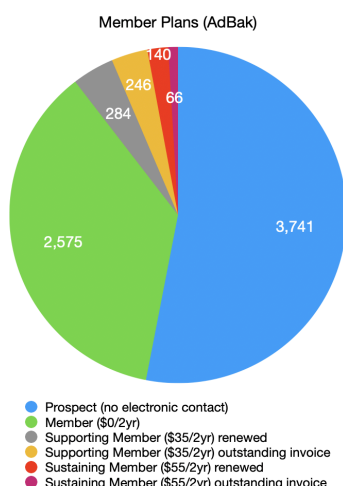
- Planning and execution of 2025 Brat Reunion in Palm Springs!
